Vermont House Overwhelmingly Passes Vermont Global Warming Solutions Act – Bill Heads to Governor Scott's Desk

We've got fantastic news to share! On Wednesday, the Vermont House passed the Vermont Global Warming Solutions Act (H.688) with 102 representatives taking a stand for real climate action in Vermont.

The 102-45 vote margin means that we expect there will be enough votes to override if Governor Scott decides to veto this pollution-reducing, job-creating bill.

Capstone Community Action Launches Mileage Smart Program – Aims to Help Low Income Vermonters Afford More Efficient Vehicles



Capstone Community Action recently launched their Mileage Smart Program to help low income Vermonters afford more fuel efficient (and cheaper to run and maintain) vehicles. The program provides an incentive worth 25% of the vehicle cost up to \$5000 to income eligible Vermonters.

Investing in a high-efficiency car that gets more miles to the gallon saves money at the pump. Additionally, fully-electric vehicles, while sometimes higher priced up front, require less maintenance over their lifetime, resulting in even more long-term savings. This innovative program is aimed to make it easier for people to save money and reduce climate pollution by lowering the upfront cost of more efficient vehicles.

Finally, there is an exciting opportunity to participate in a statewide fundraising effort that will provide direct financial support for low income weatherization needs, with money going to support Weatherization Agencies throughout Vermont.

Upcoming Webinars to Discuss Transportation Climate Initiative (TCI) -September 16th and 29th



Register now for a <u>TCI webinar on program design, modeling</u>, and the implications of COVID-19 on Wednesday, September 16, 2020, 9 - 11 AM.

This webinar will feature updates on the development of a regional low-carbon transportation policy, including presentations on new modeling results and discussion of how a regional TCI program could effectively manage a wide range of uncertainties, including those related to COVID-19. The webinar will also provide an opportunity for further public input regarding modeling and how the program could be designed to ensure participating jurisdictions achieve environmental, economic, and social equity goals.

<u>Save the Date: TCI webinar on ensuring environmental justice and equity in a regional low-</u> carbon transportation program Tuesday, September 29, 2020, 4 - 6 PM.

This webinar will focus on proposed measures intended to ensure the program fosters equity for overburdened and underserved communities, building on states' longstanding commitment to designing a program that benefits all communities, including those on the frontlines of air pollution and climate change impacts.

The COVID-19 pandemic has highlighted the fact that racial disparities in exposure to air pollution are reflected in disproportionate impacts of the coronavirus and other health threats. The TCI jurisdictions have received extensive input from a wide range of interested people and organizations on ways states could design and implement a regional low-carbon transportation program that advances equity and environmental justice. Informed by that input and further outreach, TCI state officials will provide updates on proposed strategies to ensure that overburdened and underserved communities benefit from investments and reduced air pollution and have opportunities for meaningful engagement in shaping TCI commitments and implementation moving forward.
