Join Conversation on Vermont's Long-Term Transmission Plan -March 25 at 11:30 AM



Join REV and VELCO for a conversation about the state of Vermont's electrical grid!

Every three years, VELCO, the operator of Vermont's transmission system, must update its 20-year Long-Range Transmission Plan. The plan identifies reliability concerns, transmission alternatives to address those concerns, and serves as the basis for considering whether alternatives, including new generation and energy efficiency, can meet Vermont's reliability needs. It provides information about transmission projects that may be needed to maintain grid reliability. VELCO welcomes comments on the updated draft 2021 plan date! Opportunity for Communities to Try Out On-Demand Microtransit Pilot Project



There is a unique opportunity to help your neighbors and save energy by partnering with the Vermont Agency of Transportation (VTrans) to try out an alternative transportation system as part of VTran's Mobility and Transportation Innovations (MTI) Grant Program. VTrans and the local transit provider have been working with residents in Montpelier who are part of the

Sustainable Montpelier Coalition (SMC), to roll out an on-demand transit program called *MyRide*.

The pilot program provides riders with a request-based transportation system similar to Uber and Lyft; riders can book rides from wherever they are to wherever they need to go through an app on their smartphones. VTrans has funds to support this in other similar-sized/density communities as Montpelier, but they need the on-the-ground help that the Montpelier volunteers have been providing.

The residents provide support by:

- Forming and participating in a Microtransit Advisory Committee.
- Contributing to the outreach plan associated with the microtransit pilot.
- Conduct and contribute to multiple surveys.
- Provide advocacy info and copy to local media (earned media).
- Meet with residents to assist them in uploading the app and using the service.
- Staff tables and promote the service throughout the microtransit service region.
- Meanwhile, the local transit provider plans and implements the new service and VTrans provides support in coordinating the transportation vehicles, funds, etc.

The Future of Rural Transit project aims to prepare Vermont to have the most efficient, equitable, and costeffective rural transportation system in the US by combining public, Medicaid, and school transportation into a single electrified public transportation system.

The project, which was selected by EAN members at the **2020** EAN Summit, is now looking for a partner school supervisory union and community in Vermont to study

the feasibility of combined public transit and school transportation using electric buses.

Simultaneously, renewable energy in the Sheffield-Highgate Export Interface, or SHEI for short, which stretches across parts of six northern counties — Grand Isle, Franklin, Lamoille, Orleans, Caledonia and Essex — has outstripped the capacity of rural wires. 
