The American Rescue Plan Act (ARPA) allocated nearly 180 million dollars directly to Vermont's municipalities to spend on projects related to economic recovery. Across Vermont, elected local leaders will be developing plans to invest these funds for maximum impact.

Join the Vermont Community Leadership Network on January 14th at 10:30 a.m. for a conversation with Katie Buckley of the Vermont League of Cities & Towns, and other local leaders. This online workshop is designed to help interested Vermonters understand the different

We are living in pivotal times when the decisions we make about how to transition to clean energy, manage our forests, protect our rivers and wetlands, and where and how to build housing will have lasting impacts on Vermont's resilience to climate change.

VNRC's Small Grants for Smart Growth Accepting Applications Until January 17th



VNRC continues its Small Grants for Smart Growth program with a new approach. To support the ability of communities to implement the smart growth recommendations included in the recently released Vermont Climate Action Plan, they are offering one larger grant of \$5,000 in a competitive grant round for affordable housing, sustainable transportation, or

climate resilience/adaptation solutions that meet smart growth criteria. Applications are due <u>Monday, January 17th, 2022</u>. Applications for awards of up to \$1,500 will still be accepted on a rolling basis. Learn more at https://vnrc.org/small-grants-for-smart- growth/ ×

CCRPC Funding Available for Community Transportation Projects -Applications Due January 21st



Chittenden County Regional Planning Commission announced increased funding for transportation-related projects through its Unified Planning Work Program (UPWP). The UPWP is the mechanism to implement the strategies for the region outlined in the ECOS Plan, and helps municipalities implement their local plans. Updated annually, the UPWP summarizes the transportation and land use planning activities of CCRPC

staff, its member agencies, and other transportation and planning agencies conducting work in the Chittenden County region. Through an open process, CCRPC solicits project requests from municipalities and the public on how they should invest public funds towards transportation and other planning programs in Chittenden County.×

This year, CCRPC has substantial funding to support projects in Chittenden County. If you have a transportation-related project (transportation, equity, stormwater, energy, climate, walkable community zoning, etc.) and have 20% local match available, CCRPC encourages you to apply for this increased federal funding by <u>Friday</u>, <u>January 21st</u>. CCRPC is eager to get these resources invested in your community. You can find information about the FY23 UPWP (Unified Planning Work Program) application process and forms here.

Initial Climate Action Plan Adopted by the Vermont Climate Council



Last month, the 23-member Vermont Climate Council, which was established by the Global Warming Solutions Act, adopted the initial Climate Action Plan; view a summary here.×

Key policies include a clean heat standard (like a renewable energy standard for the heating sector); a dramatically-scaled up weatherization program; a suite


of transportation investments; and a recommendation to adopt an environmental justice policy.

The plan also calls for the adoption of smart growth policy priorities that will support more climate-resilient communities through well-sited housing and other development in compact

community centers, paired with stronger protections for our forests, farmland, wetlands, rivers and other vital natural resources.

A Climate Report Card for Vermont Schools



This spring, the Underground Workshop of VTDigger, in partnership with the Vermont Energy Education Program (VEEP), is proud to offer a collaborative reporting project for Vermont's students: "A Climate Report Card for Our Schools." The project invites students from across the state to collect data, stories and interviews, comprising an evaluation of their schools' progress toward sustainability. Participation is open to

students in middle school, high school and college.

The "report card" will use five criteria to evaluate progress: heat, electricity, transportation, food systems, and curriculum. Each of these criteria will be the basis for one in a series of articles, organized by the Underground Workshop's student editors, to publish in May/June. Each article in the series will include a feature story about a specific school, along with data and examples compiled from all participating schools, providing readers with a statewide view of the issues. *****

The goal of this project is to give students leverage with policymakers and voters in their school communities and help play a small part in affirming Vermonters' commitment to sustainability.
