UPDATES & OPPORTUNITIES

AARP VT Accepting 2023 Community Challenge Grant Applications -

The annual program aims to make communities in Vermont more livable for people of all ages. AARP invites local eligible organizations and governments across the state to apply for the 2023 AARP Community Challenge grant program, now through March 15 at 5:00 p.m. Grants fund quick-action projects that help communities become more livable in the long-term by improving public spaces, transportation, housing, civic engagement, diversity and inclusion. 2023 Downtown Transportation Fund (DTF) Grant - Applications Open - The DTF has up to \$3,600,000 available to help municipalities make a variety of transportation-related capital improvements. The DTF is intended to support safe, multi-modal, and resilient transportation systems that support the downtown and village center economic development and revitalization efforts. Learn more about the program here, including if your town is eligible.

Efficiency Vermont 2023 Rebates - Are home or apartment improvement projects in store for 2023? If you plan to buy new appliances, make your space less drafty, or lower your energy costs, there may be a rebate for you. Combine those with federal tax credits and additional rebates from your electric or gas utility, and you're on your way to some serious energy savings. <u>Explore 2023 rebates here.</u>

NEWS & OP-EDS OF NOTE

Burlington Electric Department: Mayor Miro Weinberger, City Departments, Hula, BHS students, and environmental partners promote new climate policies to help city pursue net zero energy goal - Mayor Miro and environmental partners discussed a proposed policy that would require new construction for non-residential buildings over 50,000 sq ft and all municipal buildings to be fully renewable and to use renewable systems when replacing older systems. A carbon pollution impact fee would be applied for buildings that do not meet the requirements. The funds collected by the fee would fund clean heating for low-income Burlingtonians and electrify the city fleet. A substantial portion of the fee could be returned to the payer upon submission of a plan for emissions reduction or energy efficiency work. This proposed fee is subject to approval by Burlington voters on Town Meeting Day, March 7, 2023. <u>Read the full article here.</u>
