### Two Rivers-Ottauquechee Regional Commission (TRORC)

works with its 30 member municipalities, state agencies such as the Department of Public Service, and organizations such as Efficiency Vermont to plan for and implement strategies to meet the State's energy goals. This includes drafting Enhanced Energy Plans and connecting municipalities with technical and financial resources. TRORC recently hired an Intermunicipal Regional Energy Coordinator (IREC) to work with six towns to implement their energy plans. By overseeing energy-saving improvements in municipal buildings and recommending energy-related strategies and policies, TRORC and the IREC hope to make a meaningful impact on the energy use, costs, and greenhouse gas emissions of participating towns.
