This Vermont-specific "[incentive calculator](#)" gives households a personalized list of the many federal, state, and utility rebates and offers they can use for climate-friendly clean technologies and money-saving efficiency upgrades. The goal is to help Vermonters save money while improving efficiency and adopting clean technologies that use Vermont's low-carbon electricity, rather than burning fossil fuels and emitting climate-warming greenhouse gas emissions. Small Grants for Smart Growth

VNRC's *Small Grants for Smart Growth* grant program is now accepting applications for grants up to \$2,500! These grants acknowledge that community leadership and small steps are essential for catalyzing change. Think creatively about how you can advance smart growth in your town, and consider applying today. Or, help us spread the word - these grants are available to support a broad range of creative community projects. A project could be a town or local group effort to promote downtown or village center revitalization and historic preservation; to develop a plan for better sidewalks or paths; to identify ways to support housing choice and affordability; or to plan on conserving land for agriculture or forestry. Submit a Proposal to Speak at REV2024

Save the date - the REV2024 Conference will be on Wednesday and Thursday, October 16 & 17 in Burlington. Take a moment to review the [RFP guidelines and submit a proposal](#). You do not need to have a complete panel with confirmed speakers to apply. It is more useful that REV receives your idea by the deadline rather than waiting for the application to be "complete." Submissions that bring first-time REV Conference presenters are encouraged. IMPORTANT: REV is committed to supporting a diverse workforce and uplifting diverse voices and perspectives in the industry. As such, all sessions at REV2024 must feature gender and racially diverse voices and no panels will be considered if they do not reach this criteria. We will only reach a sustainable, inclusive 100% renewable energy future by creating space and adding weight to all voices.

Community Capacity Building Mini-Grants Deadline May 31st

These grants fund municipal efforts for capacity building and active participation in energy resilience initiatives, specific to MERP and beyond. Municipalities may conduct community education and outreach regarding Vermont's climate policies and incentives to cut energy costs, lower greenhouse gas emissions, and improve energy resilience in municipally owned buildings. These grants can also be used to identify potential candidate buildings for MERP's free Energy Resilience Assessments and Implementation Grants of up to \$500,000. VPIRG Briefing on the Climate Change Super Fund

Please join VPIRG on Thursday evening, **May 2, at 6:00 p.m.** for an online VPIRG member briefing on S.259, the Vermont Climate Superfund Act.

This legislation, which will hold the largest fossil fuel companies accountable for a fair share of the climate crisis and reduce the costs that Vermonters pay, passed the Senate last month on a tri-partisan vote of 26-3. It is now under consideration in the House. The House Environment & Energy Committee approved it last week, and the Judiciary Committee is scheduled to vote on it this afternoon. Cash for Communities: Leveraging Historic Federal Funds for Racial, Economic, and Climate Justice

Local energy leaders have a critical role in ensuring that federal funding reaches the communities that need it most. Thanks to Direct Pay tax credits, tax-exempt entities like municipal and county governments, schools, and community-based organizations can receive federal funding for building clean energy projects but need help from local leaders! Local electeds can use local funding and policymaking tools to help tax-exempt entities take full advantage of Direct Pay and expand publicly-owned clean energy. Join the Congressional Progressive Caucus Center and the Local Progress Impact Lab on **Thursday, May 9th, at 1 PM ET/ 10 AM PT** to learn how local leaders can champion Direct Pay as community educators and policymakers.
